Terms and Conditions of Membership

1. Tropics Golf Club

Tropics Golf Club is owned by a private company. All property, equipment, licences and staff are controlled by the companies through their appointed General Manger. All inquires relating to the Golf Course should be directed to Management.

2. Financial/Membership Year

The Membership year for Tropics Golf Club memberships is for 12 months commencing on the date of the Membership application.

3. Membership Benefits

Transfer of entitlements – Membership packages have been formulated to provide a versatile range of benefits. All entitlements are conferred to the owner of the Membership only and cannot be transferred, sold or gifted to any other personal without exception. Members found to be in breach of this condition will be subject to immediate suspension of entitlements. Members must report to the Pro Shop (Starter) to produce their current Membership card and pay appropriate fees, prior to all play without exception. Failure to produce current Membership card shall result in full green fees charged or refusal of play.

4. Bookings

Members are requested to book games online through Member bookings or through the Pro Shop. Members should note the club's rules for all competitions. Players are required to register at the Pro Shop at least 15 minutes prior to scheduled tee time. In the event of a cancellation, players are to advise staff, preferably the previous day. Failure to comply with these club rules will be dealt with by Management and could result in loss of competition, disqualification and suspension.

Membership by laws:

- a) These rules apply to all persons who have applied for and have been accepted for Membership of whatever type.
- b) These rules shall form the basis of the member's relationship with the proprietor and operator of the Tropics Golf Club respectively and between all other members.
- c) There is distinction of members rights by virtue of gender.
- d) All of the facilities which comprise the Tropics Golf Club are privately owned. Tropics Golf Club confers no rights or obligations with respect to its property, assets, liabilities or management or any person by acceptance of their application for Membership.
- e) Tropics Golf Club may reject any application for Membership or renewal of Membership, without assigning reason(s).
- f) It may establish and adjust fee structures and make rules for management of its facilities. This includes but is not limited to from time to time adjustment of booking times, hours of operation and the closure of the facilities for tournaments, weather conditions, maintenance or other reasons.
- g) Members must abide by these Membership Rules and also Code of Conduct which apply to all persons using the facility.
- h) Members must carry their Membership card at all times while using the facilities at Tropics Golf Club and may not be entitled to some benefits without production of it. The benefits of the Membership shall not be available beyond the date of expiry.
- i) Members must not allow their Membership card to be used by any other person and members must notify the Membership coordinator immediately if their card is lost.
- j) Tropics Golf Club may cancel the Membership of any person or refuse permission for the person to use its facilities if that member continuously, or substantially breaches these rules, or is guilty of misconduct within the facility or elsewhere which at the option of Tropics Golf Club, is contrary to the best interests of other members or reflects badly upon Tropics Golf Club or fails to make a payment within 14 days after a written reminder of the sum due.
- k) No refunds are payable for the termination of Membership from any cause.
- l) Handicaps will be maintained by Tropics Golf Club for all Members who nominate it as the 'home club' for the purposes of the Handicapping rules of the Australian Golf Union and Women's Golf Australia. Handicaps will be maintained by Tropics Golf Club in accordance with those rules. Handicaps of members shall be available from the Pro Shop located within the Clubhouse. Tropics Golf Club shall not be liable, in any way, to the members in respect of any errors or omissions made in keeping of handicaps. Members may obtain a current handicap certificate, without fee, by applying to the Membership coordinator.
- m) Members exercise their rights and come upon and use of the facilities of Tropics Golf Club at their own risk. Tropics Golf Club will not be liable for damage to any person or damage or loss of property. Each member indemnifies and keeps indemnified Tropics Golf Club its staff assisting against any loss or damage to any person or property howsoever arising and whether cause within the facility.
- n) These Terms and Conditions of Members code of Conduct are designed to aid efficient operation of the facilities of Tropics Golf Club for the benefit of all. They may be changed by management of Tropics Golf Club at any time. Notice of changes will be posted on the Clubhouse notice board.
- o) No personal alcohol, food or drinks; other than fruit, water etc. Are permitted on the property and course. Please advise our chef of any personal dietary requirements. We reserve the right for any inspections

Terms and Conditions of Periodic Membership Payments

1. Tropics Golf Club

Tropics Golf Club is owned by a private company. All property, equipment, licences and staff are controlled by the companies through their appointed General Manger. All inquires relating to a Membership Loan should be directed to Management.

2. Financial/Membership Year

The Membership year for Tropics Golf Club memberships is for 12 months commencing on the date of the Membership application.

3. Membership Monthly Payments

A member may apply. Management may decline without giving a reason. Monthly payments will incur a 10% admin fee for each monthly payment.

4. Membership Instalment Payments

- a) All instalments must be paid on or before the nominated instalment dates.
- b) Failure to pay an instalment on time will result in immediate suspension of member privileges until instalments are brought up to date.
- c) Instalments must continue if the member's privileges are withdrawn for disciplinary reasons.
- d) Future Membership applications will only be accepted if all past loan instalments have been paid.
- e) First instalment includes third party affiliation fee of \$100.
- f) Following the first instalment, there will be 10 further instalments.
